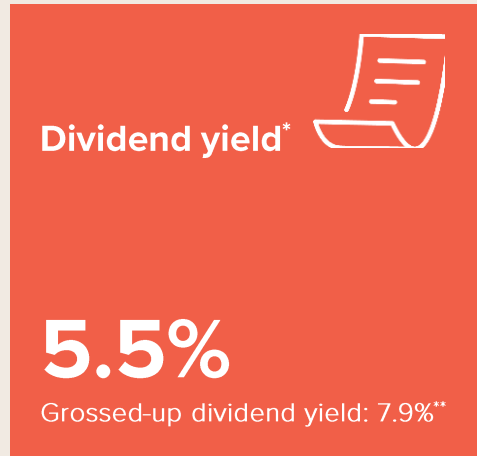

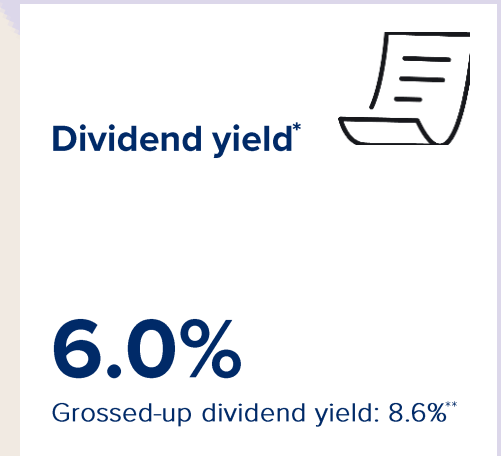


Future Generation Australia (ASX: FGX)

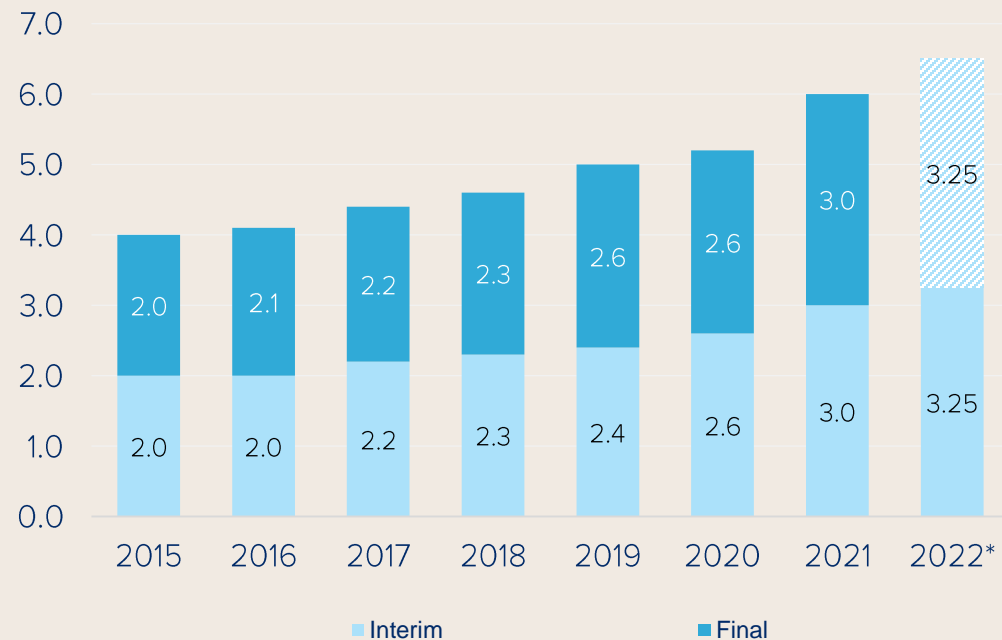
Future Generation Global (ASX: FGG)

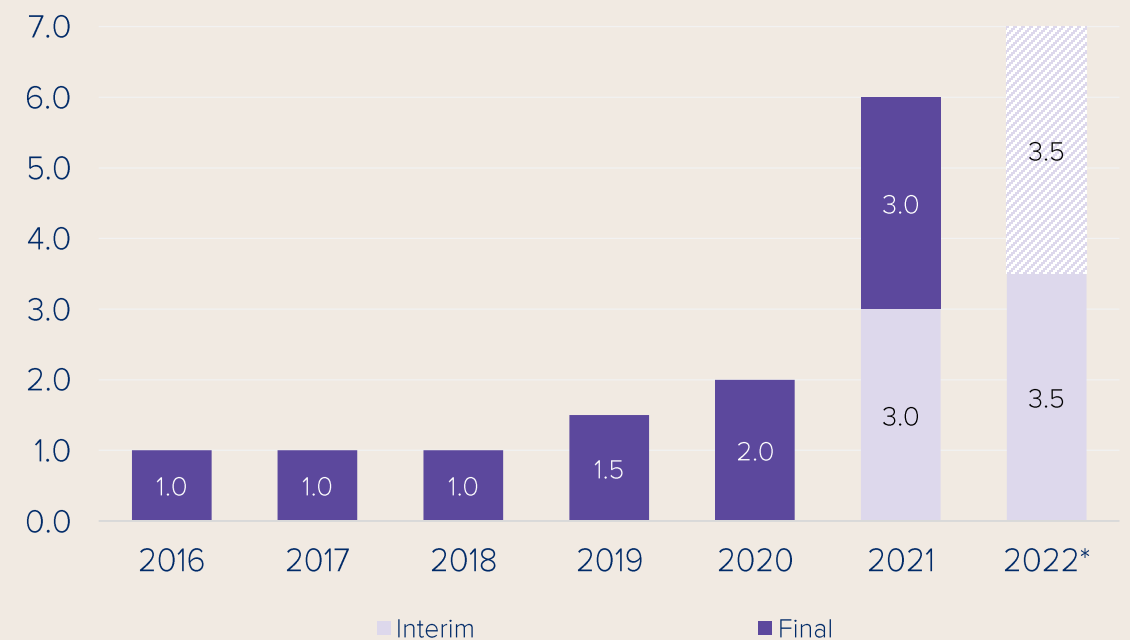
Fully franked dividends since inception
