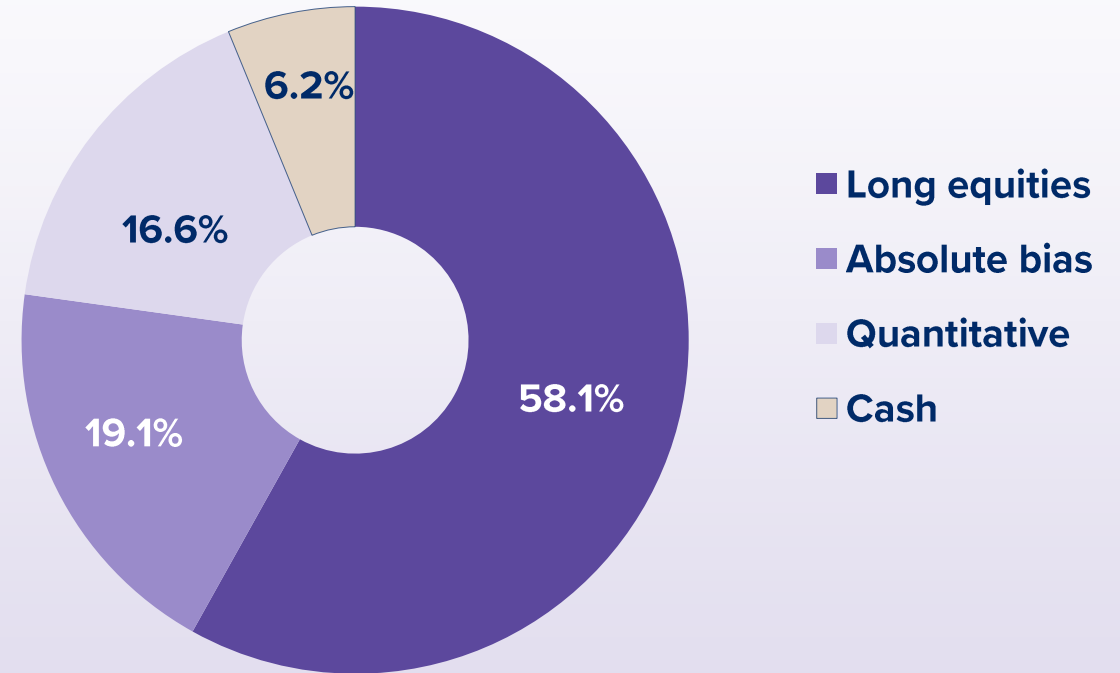

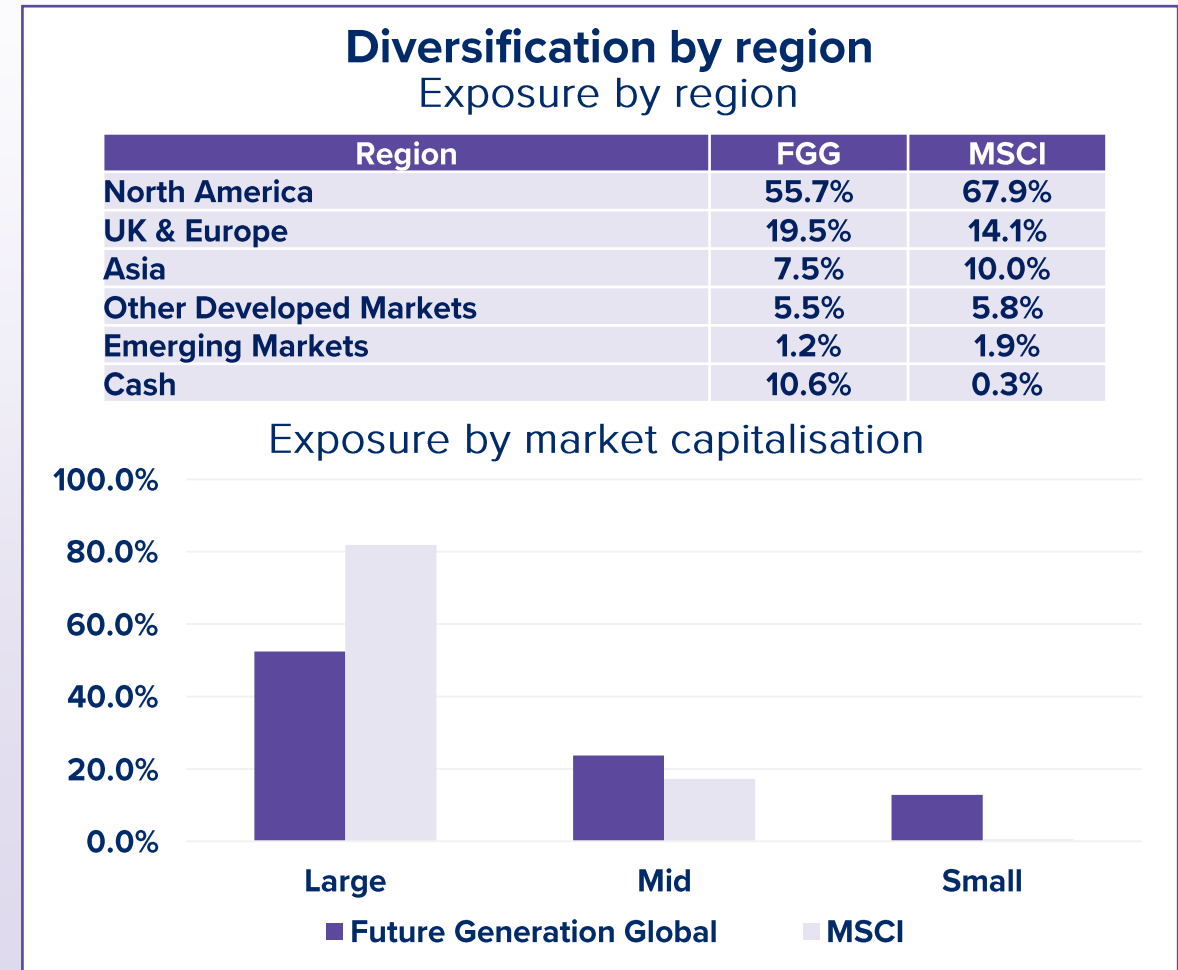
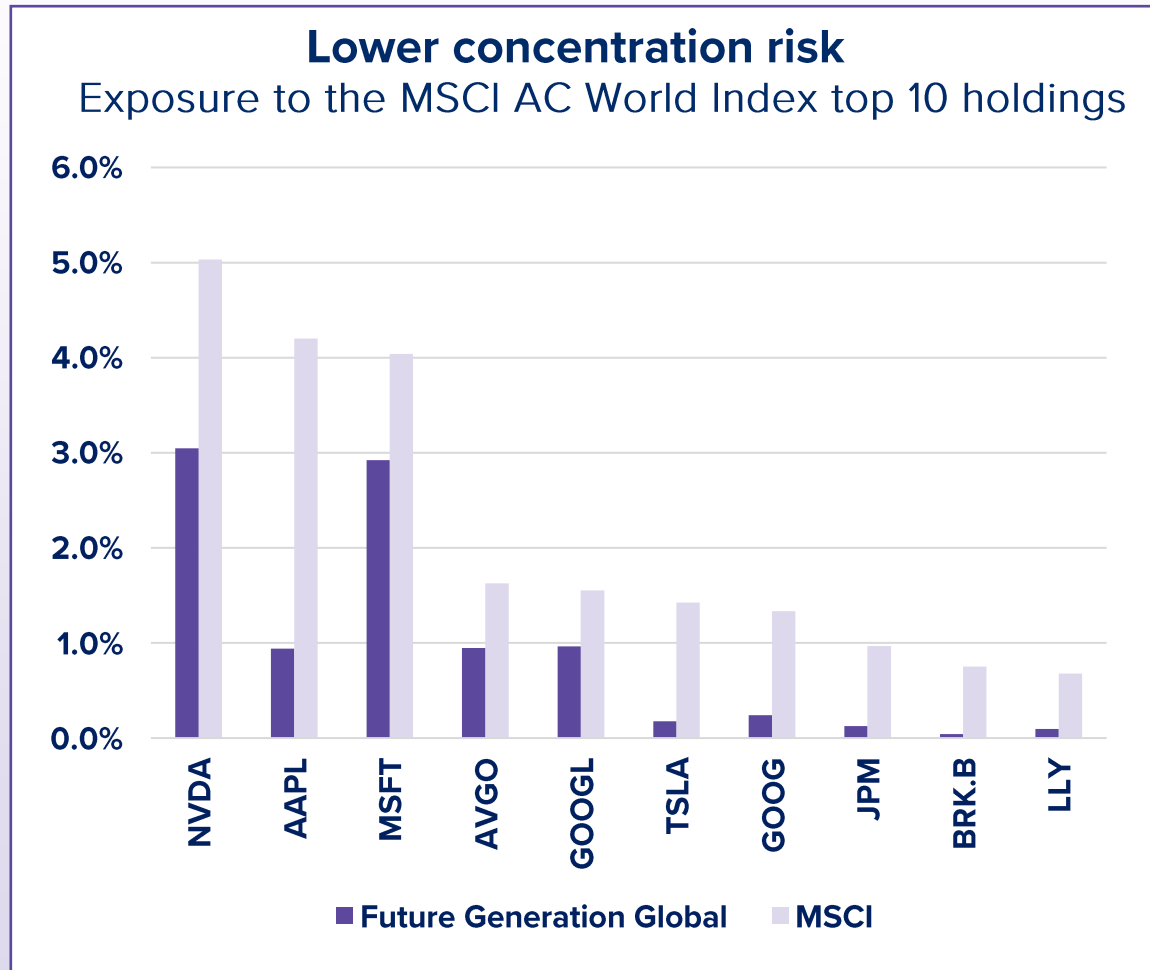
Diversified global investment portfolio

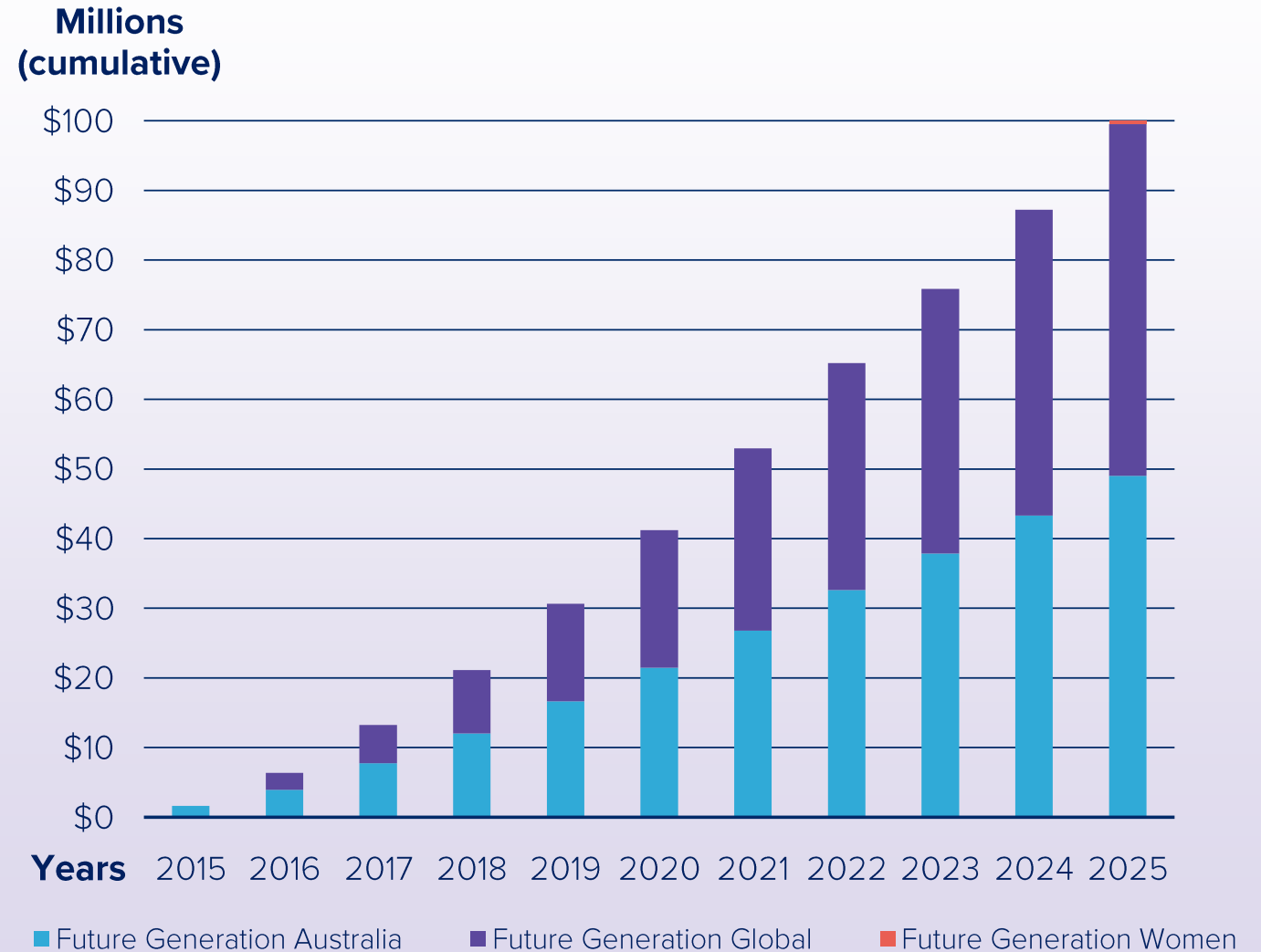
